Base Erosion and Profit Shifting (BEPS)

Possible disclosure of sensitive information pursuant to the country-by-country reporting; and the OECD consultation on the eligibility for tax treaty benefits of non-collective investment funds in light of the OECD's "Treaty Shopping" proposals. Sovereign wealth funds could be at a competitive disadvantage if similar treatment is not available to them or their investment vehicles.

US Tax Reform

The suggested reforms to the Foreign Investment in Real Property Tax Act (FIRPTA) currently suggested that foreign pension schemes will be the only beneficiaries of any changes. These reforms could put sovereign wealth funds at a competitive disadvantage in relation to new US infrastructure and real estate investments, as well as limited partners of US limited partnerships.
